Ordinance 22-004 An Ordinance to add territory to the UIRVDA Enterprise Zone on behalf of Building Materials Manufacturing Corporation in Peru, LaSalle County IL-The Building Materials Manufacturing Corporation (BMMC) is planning the acquisition of approximately 130 acres of land in the City of Peru, Bureau County to construct a 400,000 square foot manufacturing facility with the potential for future expansion. The proposed site development plans include rail infrastructure, improvements, primary and secondary road access to the site and areas for truck staging and loading. The total project investment is approximately \$82,750,000 and will create 72 new jobs with an estimated annual payroll of \$4.7 million.
